Candidates are asked to submit a one page summary of their qualifications, goals, and why they want and deserve the scholarship.

## **Terms and conditions**

The Norhurst Scholarship recipient agrees to use the monies provided by Norhurst for the recipient's school tuition and fees and /or books/required reading material for classes pertaining to recipient's major or general study classes. Norhurst reserves the right to inquire or investigate how scholarship monies are appropriated. In the event of intentional misappropriations of Norhurst Scholarship monies, Norhurst has the right to revoke the scholarship and suspend any unused monies.

--The Norhurst Scholarship recipient must have graduated or be on-track to graduate high school. Recipient must also finish in the top half of your graduating class, achieve a minimum GPA of 2.75, and score 860 on the SAT or 16 on the ACT. NOTE: If the Norhurst Scholarship recipient attends a school or university that has a higher eligibility standard (than required by Norhurst) to attend that institution, the Norhurst Scholarship recipient must meet the minimum requirements of that institution and meet the designated institution's requirements in order to receive the Norhurst Scholarship monies.

--Unless noted otherwise, you must be a U.S. citizen or permanent resident, Thirteen years of age or older as of the date of entry to be considered for Norhurst scholarship awards. If the recipient is below the age of 18 when enrollment of the specified college/university takes place, Norhurst may list the recipient as the parent/legal guardian as the recipient of the scholarship in accordance with the law and specific university/college policy. Norhurst will comply with the recipient school's regulations with regards to the release and dispersion of funds.

--You must provide your mailing address on the application so that we can send you paperwork to complete if you are selected as a scholarship recipient. The potential recipient must agree and perform an in-person interview, if requested, by the Norhurst Board of Directors or any of the executives of Norhurst in direct correlation to the discussion of granting of the Norhurst Scholarship. If requested, the potential recipient may also be required to prove their GPA via written transcript from the attendee's high school and/or a written recommendation from a teacher at the potential recipient's high school.

--To be awarded a scholarship, a recipient must enroll within 12 months of scholarship grant, at an accredited college or university located in the United States. Scholarships proceeds will be remitted to that school during the summer before the student attends, or the end of the first calendar year the student is enrolled. The summer before the recipient attends the college or university, they will need to complete a Payment Form that says which school they will be attending, and specifically where at the school to send the award payment. If this form is not completed, the award will not be disbursed, and the recipient may forfeit the award.

--By applying for a scholarship, applicant grants Norhurst permission to post their name on Norhurst or in other marketing communications in the event they are awarded the scholarship. Scholarship recipients will be required to submit a current photo and submit a publicity release granting Norhurst permission to use their photo on Norhurst and in other marketing communications.
